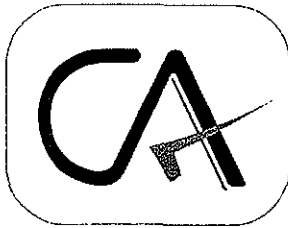


Review Report to the Board of Directors of HI-KLASS TRADING & INVESTMENTS LIMITED.

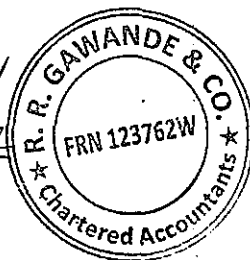
