JAPANESE AUTOMOTIVE **GIANT** Honda is re-evaluating its global priorities, and has said that India is one of its three key markets for future growth, placing it alongside the US and Japan.

In an interaction with reporters on the sidelines of the Japan Mobility Show 2025 in Tokyo, Takashi Nakajima, president & CEO of Honda Cars India, said that the global management has decided to focus on India among the three key markets for Honda's future growth, alongside the US and Japan. "Our two-wheeler business

is already very big in the country, and we are aiming to follow a strong growth direction for our four-wheeler business by building both brand and volume," he said.

To realise this goal, Honda is charting an aggressive product roadmap, and a key focus will be the growing SUV segment – and Honda plans to introduce three new SUVs by FY27. These models will encompass both hybrid and battery electric powertrains.

Nakajima said that the carmaker would focus on a multipowertrain approach, gradually increasing the share of BEVs to align with its global goal of achieving carbon neutrality by 2050.

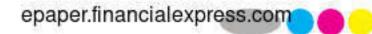
